

## **Conditions of Participation**

Offers 2024

In connection with the offerings of our association, healing means the becoming whole of body, mind and soul and not recovery or healing of suffering in the conventional medical sense. Participation in our offers does not replace medical or other therapeutic treatment in the sense of conventional or complementary medicine. Treatment is generally only reserved for a doctor or therapist. For the sake of language flow and for general better understanding, the word treatment is also used in shamanic applications in the sense of application instead of treatment.

Registration for one of our offers is only accepted in writing or via an online registration form.

After registration, information on the details of the respective event as well as booking and payment options will be sent. The booking of an event is only valid once it has been paid for.

General cancellation conditions:

If you are unable to attend, you are free to name a replacement participant and 10% of the event amount must be paid as a processing fee.

You can cancel your registration free of charge up to 30 days before the start of the event; After that, a processing fee of 30% of the event amount must be paid up to 7 days before the event. If you cancel 7 days before the event or do not show up, the total amount is due.

Special cancellation conditions (e.g. with externally invited speakers, Pagos and teachers)

If you are unable to attend, you are free to name a replacement participant and 10% of the event amount must be paid as a processing fee.

If you cancel up to 30 days before the start of the event, a processing fee of 10% of the full event price is due; After that, 70% of the event fee must be paid up to 7 days before the event. If you cancel 7 days before the event or do not show up, the total amount is due.

Please note that in order for an event to take place, a minimum number of participants is required, which can be found in the respective event announcement. If the minimum number of participants is not met, the event unfortunately cannot take place and the booking amount will be refunded to you immediately. Please also note that the practices presented in the events are not medical or therapeutic treatment and cannot/should not be a substitute for such treatment. Participation in the event offered by Kuychichaka is voluntary. Each participant bears full responsibility and liability for themselves and their actions within and outside of this event. By submitting a valid and signed registration, each participant guarantees that he/she is physically and mentally healthy; otherwise, he/she is obliged to report any health impairment to the event manager before the start of the event. The association reserves the right to reject registrations for its events, as well as to make scheduling deviations and minor changes to the content, depending on the resulting group process.
